SUBJECT: Notification of Intent (NOI) to Issue and Invitation for International Competitive Bidding (ICB) for the Provision of Financial Support Services for Allied Command Operations (ACO).

1. In accordance with the stipulations of the Bi-SC Procurement Directive 060-070 dated 30 June 2015, Annex C, the following information is provided on an Invitation for International Competitive Bidding (ICB) that this Headquarters has the intention to release.

Requirement : The Contractor shall provide Financial Support Services to the SHAPE FINAC Directorate within the ACO Corporate Accounting and Control Branch. Contractor's proposed personnel shall be in possession of NATO SECRET security clearance.

Type of contract : Requirement Contract

Period of performance : 01 January 2021 - 31 December 2021 with possibility to exercise up to 4 one-year options

Bidding procedure : Sealed Bidding (technical/financial) – the ACO electronic bidding portal will be used to compete this ICB (<https://aco.procureware.com>). **Firms not already registered on the portal are encouraged to apply for registration**

Eligibility : Governmental or Commercial entities (1) that originate and are chartered/incorporated within NATO-member nations, (2) that maintain a professionally active facility (office, factory, laboratory, etc.) within NATO-member nations and (3) that provide the funding for the aforementioned requirement. Companies which have performed at least two contracts within the last five years substantially similar in scope, complexity and magnitude to the requirement described in the solicitation
