# <u>ANNEX B</u>

# Summary of Requirements

### 1. Background

- **1.1.** The NCI Agency, has an intent to increase the security level of its supply chain operations and perform compliance checks on the prospective suppliers that plan to conduct business with the NCI Agency. The purpose of this intent, is to identify the ultimate beneficiaries of transactions, as well as clearance with sanctions, antiterrorism and money laundry lists, ensuring that the NCI Agency fulfils the 'know your business' requirements. These compliance checks could also be performed at the transactional level on an ongoing basis.
- **1.2.** There are certain online tools available to perform such compliance and sanction list checks which can enhance the compliance level of operations.

### 2. Purpose

- **2.1.** The purpose of this project is for the NCI Agency to have access to up to date databases in order to perform such compliance checks as a regular and integrated part of supplier onboarding process as well as enabling these compliance checks at the transactional level [Control at Transaction / disbursement time frequency to be determined].
- **2.2.** As banks are requesting more and more detailed information about the payments and suppliers related to potentially risky transactions, the NCI Agency needs to provide confidence to the banking partners that all necessary compliance checks have been performed and that there is a robust counterparty risk management process in place.
- **2.3.** The NCI Agency intent is also to know available tools that can help to improve the procure to pay (P2P) process controls.

### 3. Project Scope

- **3.1.** The NCI Agency is exploring the potential for industry to provide commercially available tools that would allow the NCI Agency to perform digital compliance checks on the companies before onboarding them as suppliers and enable similar automated compliance checks at transactional level as part of the standard vendor data management and payment processes within P2P.
- **3.2.** The main objective of this task is to perform compliance checks against sanction lists (i.e. run single searches against a consolidated list of major global sanctions lists like for instance US sanction list (OFAC), European list Common Foreign & Security Policy (CFSP), etc).
- **3.3.** The Agency aims to increase the efficiency and effectiveness of P2P process controls.

- **3.3.** Three options are being considered for this business requirements:
- **3.3.1.** Under option A Basic requirements
- **3.3.2.** Under option B Advanced requirements
- **3.3.3.** Under option C Future or integrated requirements
- **3.4.** Business Requirements: all options should have the possibility to be integrated with the Agency ERP (Oracle based) system and TMS (Treasury Management System)

#### 3.4.1. BASIC – OPTION A

- **3.4.1.1.** For compliance checks at Supplier Creation (Ad-hoc compliance checks) the tool should enable the NCI Agency to check if the prospective supplier or any of its' related parties (main shareholders, sister companies, subsidiaries, etc.) are on any sanctions lists (consolidated list of major global sanctions lists).
- **3.4.1.2.** For ad-hoc compliance checks the tool should allow automated compliance checks on the existing supplier database with possibilities to upload the existing supplier base and run automated compliance checks.

#### 3.4.2. ADVANCED – OPTION B

- **3.4.2.1.** For compliance checks at the transaction level similar automated compliance controls at the transactional level on the payment batches before sending them to the banks for execution.
- **3.4.2.2.** The consolidated sanction lists should be current and comprehensive.
- **3.4.2.3.** In case of any red flags, a detailed report of the underlying reasons should be available.
- **3.4.2.4.** In addition to the above, the solution should be in compliance with NATO Cyber Security and related technical requirements that will be provided at the RFQ stage.

#### 3.4.3. ENLARGED SCOPE - OPTION C

- **3.4.3.1.** Tools that provide full set of Bank databases in SWIFT network, especially covering the banks based in NATO nations, with a possibility to upload in to the NCI Agency's tool (EBA Oracle based system) without disturbing ongoing transactions in the system.
- **3.4.3.2.** Payment tracking tool that enables the NCI Agency's Treasury department to follow-up on the status of the unique payments with an option to recall before it arrives at the beneficiary's bank account.
- **3.4.3.3.** Transaction screening tool (pre-validation) that controls the payment details of the transaction in the payment batches and raises red flags where it finds incompliances (e.g. beneficiary name is different, etc.)
