1. In accordance with the stipulations of the Bi-SC procurement Directive 60-70, Annex C, the following information is provided on an Invitation for International Bidding/Proposal (IFIB/IFIP) that this Headquarters has the intention to release.

Title of IFIB/IFIP : Provisioning of Maintenance to the Security System at HQ AIRCOM

Type of contract : Firm Fixed Price Contract

Period of performance : One Base Period: 01 January 2023 – 31 December 2023 with a further four (4) one-year extension options as per para 2-12 (b) of above mentioned directive.

Bidding procedure : Lowest price technically compliant; the ACO eBid portal will be used for the competition URL: <https://aco.procurement.com>

Eligible firms who are interested to participate in this competition are invited to apply for registration on the ACO eBid portal unless they already hold status of approved/registered vendor.

Funding : Yearly estimated cost 87.000 €. The estimated total contract value is 435.000 €

Classification : NATO UNCLASSIFIED

Issue Date : 25. April. 2022

Closing Date : 04. Oct. 2022

Eligibility : Restricted to **Governmental or Commercial entities (1) that originate and are chartered/incorporated within NATO-member nations, (2) that maintain a professionally active facility (office, factory, laboratory, etc.) within NATO-member nations and (3) that provide the funding for the aforementioned requirement. Companies which have performed at least one contract within the last five years substantially similar in scope to the requirement described in the solicitation**

**Note: A NATO Security Clearance (classification NATO SECRET) for bidders and contractor's personnel is required**
