Title of IFIB : Renovation of water softening installations on the SHAPE compound
Requirement : The project consists in the dismantling and removal off-site of the water softeners as well as all of the fittings. The new water treatment installation shall consist of 5 water softening columns.
Type of contract : Firm-fixed price
Period of performance : One-time
Bidding procedure : Lowest technically compliant bid
Funding : SHAPE budget (estimated total value: 270 KEURO)
Issue Date : June 2022 planned
Bid Closing Date : August 2022 planned
Classification of IFIB : NATO UNCLASSIFIED
Eligibility : Firms (1) that originate and are chartered/incorporated within one of the 30 NATO-member nations, (2) that maintain a professionally active facility (office, factory, laboratory, etc.) within one of the 30 NATO-member nations, (3) that have performed at least three contracts within the last five years substantially similar in scope and magnitude to the requirement described in the solicitation.
