Subject: **Notification of Intent** (NOI) to issue an Invitation for International Bid (IFIB)

1. In accordance with the stipulations of the Bi-SC procurement directive 60-70, Annex B, the following information is provided on an Invitation for International Bid (IFIB) that this Headquarters has the intention to release.

IFIB reference number : ACO-SH-22-13
 Title of IFIB : Supply and installation of Chemical, Biological, Radiological and Nuclear (CBRN) filters and Carbon Dioxide (CO₂) filters in the SHAPE Command Center (SCC).
 Requirement : The requirement is for the supply and installation of the following quantities and types of filters: Q.ty 75 CBRN filters and Q.ty 45 CO₂ filters.
 The work shall include:
 - The provision of all labour, materials, equipment and services required to supply and install the new filters.
 - The removal and disposal of the existing filters.
 Prospective bidders shall be in possession of a valid NATO security clearance up to NATO SECRET.

Type of contract : Firm-fixed price.
 Period of performance : One-time.
 Bidding procedure : Lowest price technically compliant bid.
 Funding : NSIP funding.
 Issue Date : End of August 2022, planned.
 Closing Date : October 2022, planned.
 Classification of IFIB : NATO UNCLASSIFIED.
 Eligibility : Firms (1) that originate and are chartered/incorporated within one of the 30 NATO-member nations (2) that maintain a professionally active facility (office, factory, laboratory, etc.) within one of the 30 NATO-member nations, (3) that have performed contracts within the last 5 years substantially similar in scope and magnitude to the requirement described in the solicitation. (4) Due to the nature and peculiarity of the project, the Investment Committee (IC), has authorized to enlarge the invitation to firms from Switzerland that have performed contracts within the last 5 years substantially similar in scope and magnitude to the requirement described in the solicitation.
