Title of IFIB: Non Armed Security Guards Services to the NISRF Compound and premises

Requirement The purpose of this Invitation for International Competitive Bids (ICB) is to award a firm fixed-price contract to provide Non Armed Security Guards Services to the NISRF Compound and premises, Sigonella AFB, Italy. Contractor personnel performing services under the contract must be citizens of a NATO nation, possess at least a valid NATO Secret level security clearance.

Type of Contract: Firm Fixed Price (FFP).

Period of Performance: Base Award: 1 Jul 2024 – 31 December 2024, Option Period 1: 1 January 2025 – 31 December 2025, Option Period 2: 1 January 2026 – 31 December 2026, Option Period 3: 1 January 2027– 31 December 2027, Option Period 4: 1 January 2028 – 31 December 2028.

Bidding Procedure: Lowest Price Technically Compliant. Competition will be conducted on ACO Electronic Bidding Portal.
